

NATIONAL WATERCOLOR EXHIBITION

Cats and dogs

AKVART gallery 7.–27.1.2019, Humalistonkatu1, 00250 Helsinki

AKVART gallery cooperative invites watercolor artist to offer their paintings to a cat- and dog-themed exhibition held in GALLERY AKVART, Humalistonkatu 1, 00250 Helsinki, 7.–27.1.2019. AKVART's the cat and dog exhibition is open to all Finnish and watercolor painters and artists groups living in Finland, as well as academics of visual art. Applying for the exhibition does not require membership of the gallery cooperative.

Watercolor paintings offered for the exhibition must be completed in 2016-2018. **The paintings must present one or more animals belonging to Felidae tai Canidae family.** Representatives of both families may also be present in the same painting. The work is defined as watercolor if more than half of the work is based on watercolor technique. The maximum dimension of the works must be 56 cm (including three-dimensional). The work choices are made on the basis of electronic application material. The Jury is visual artist Kati Immonen.

Application: Picture files of 1–3 art works are sent by email to address jyrytysakvart@gmail.com by **23.11.2018** midnight. With the picture files, the applicant will provide basic information about himself (name, address, email, phone number) and his / her works. Images should be of good quality (longer side at least 600 pixels). The entire painting should be shown in the picture. The painter's name may not appear in the image and will not be told to the Jury. Information required for each painting are the name of the work, dimensions (height & width without frames / passe-partouts), year of completion and selling price. Application fee: Applicants pay **30 € to AKVART gallery's account FI24 5789 5420 0472 06, reference number 11413.** The fee entitles participation of 1–3 works into the selection process and must be paid **23.11.2018** at the latest. The payment will not be refunded. If the payment has not been made the application will be rejected.

Shipping, insurance and painting sales. The artist is responsible for the transport costs of his / her works. AKVART is responsible for the insurance of the exhibition. From the sale, AKVART will charge 25% of the sales commission from non-cooperative members and pay the artist the rest of the sale price after the exhibition.

Artists selected for the exhibition will be announced on AKVART's "Tiedotuksia 2018" (Announcements 2018) website at week **49** at the earliest. The results will be announced to the selected artists by e-mail.

Participation fee. Artists selected for the exhibition will pay 40 € participation fee for 1–3 works to gallery's account **FI24 5789 5420 0472 06, reference number 11426.** Payment must be made by the end of December 2018.

The **image usage** of the works selected to the exhibition is transferred to AKVART for marketing purposes.

Delivery of works. The selected works must be delivered to AKVART (Humalistonkatu 1, 00250 Helsinki) with pseudonym "Kissat ja koirat" (Cats and dogs) by freight or by post in the canton of the first week of January. If there are problems with the delivery of books, call Tuula Palmunen-Saari 0407690292. The works must be marked in the same way as the electronic application form (artist, title and year of completion) and the works must be ready for hanging.

The selected artists participate in **exhibition supervision** in the gallery. If the artist can't perform his / her supervision, there will also be available substitutes of 35 € / day for expenses.

After the exhibition, the works must be taken from the AKVART Gallery by the end of February.
